#### SENIOR REPRESENTATIVE:


To qualify seniors representative level, at least 3 direct representative under you are required, to get 2% additional Commission on complete downline of your qualified direct representatives.

\* Sales Representatives will be paid on target based commissions as mentioned above in monthly income slabs, however, it does not include any additional fixed pay or in-house labour benefits other than commissions.
